**APPLICATIONS MUST BE ACCOMPANIED BY WRITTEN PERMISSION TO HUNT.  
DETAILS OF THE PERMISSIONS REQUIRED ARE SET OUT AS FOLLOWS:-**

**PRIVATE LANDS**

In the case of private landowners this should be in the form of a short note or letter stating that they have given permission to the applicant to hunt deer on their land. It should state the landowner's name and full address, also the townlands where the hunting is to take place and (very importantly) it should be currently signed and dated. Please provide folio numbers for the lands over which you intend to hunt.

**LEASE OR LETTING**

In the case of a lease or letting of Sporting Rights, proof must be provided in the form of a letter or copy of a permit from the owners, eg, Coillte Teo. Receipts/invoices will not be accepted.

**NOMINATED STALKER**

If the applicant is a guest or a nominated stalker on a lease or letting, they must provide written confirmation from Coillte Teo confirming this.

**CLUB OR ASSOCIATION**

If the applicant intends to hunt deer on lands owned or leased by a Gun Club, Game Association etc., they should provide (current) written proof of their membership.

**OWN LAND**

The only exception to this requirement, is a person who is shooting exclusively on his or her own land, providing they are entitled to the Sporting Rights on that land.

**NOTE**

The registered owner of land, may not necessarily own (or be entitled to use) the Sporting Rights over his or her land.

**ATTENTION**

**Any person who, for the purpose of obtaining a licence under the Wildlife Act 1976 (As Amended), makes any statement or gives information which they know to be false shall be guilty of an offence. Penalties include fines and forfeiture of firearms.**

In order to avoid unnecessary delay in processing your application please ensure that you have fully completed this form and that you have enclosed written permission(s) to hunt.
